

## Why hire a vocational evaluation expert?

Expert testimony by vocational evaluation consultants is becoming increasingly common in litigation involving claims of loss of employability and earning capacity. This well-established practice clearly reflects the practical value of documented opinions from respected experts in this highly specialized field. Grounded in extensive research and precise analysis, expert opinions provide objective, quantifiable measures of vocational damages suffered. Experience continues to show vocational evaluations to be persuasive to the court and effective in facilitating equitable solutions.

These benefits become clear in the context of typical litigation scenarios in which vocational evaluation experts are *not* called as witnesses. Personal injury cases often rely on testimony from doctors assessing the degree of a person's disability. Even in cases in which the doctor asserts that the person is completely disabled, attorneys, judge and jury must make judgments that ultimately are subjective in economic terms.

An economist might testify about projected loss of earnings for a high school graduate versus a college graduate, using analysis of economic statistics, but the testimony lacks particulars about the injured party's unique circumstances. In divorce petitions in which employability is a key factor, earning capacity projections frequently rely on the widely divergent opinions of the claimants.

In practical terms, "expert opinions" such as these leave substantial room for interpretation. Even when using guidelines issued by judges, juries are left to translate generalities into personal terms, often resulting in awards that are unacceptable to one or both parties, with no objective standard for resolution.

Qualified vocational evaluation experts can eliminate or minimize the gray zone in these cases by establishing objective parameters for quantifying vocational damages—such as loss of earning capacity in specific markets or the extent of residual employability. Comprehensive reports

that satisfy all parties also are valuable resources for facilitating settlement without the expense of jury trials.

For personal injury litigation, additional benefits can be achieved using vocational evaluation experts with integrated capabilities in earning capacity analysis, life care

analysis, life care planning for long-term medical needs, and assistive technology evaluation for optimizing the income potential of functionally impaired individuals. In all cases, effective use of vocational evaluation experts in litigation depends on credibility and experience.



#### **VOCATIONAL EVALUATION**

Our analysis of employability and earning capacity provides attorneys with reliable, individualized hard data for negotiating appropriate awards in personal injury cases and determining spousal earning capacity in divorce cases. We effectively apply similar methodology to a wide range of other litigation, including workers' compensation, discrimination and medical malpractice lawsuits.

Kincaid Vocational Services collects the necessary data by conducting personal interviews, compiling and evaluating medical and employment histories, and conducting skills and aptitude testing as



appropriate. In addition, we investigate regional labor markets to assess available opportunities. Our evaluation of individuals' functional capacity includes the full range of physical, intellectual, cognitive and psychosocial capabilities.

We use advanced earning capacity modeling and other leading computer-based tools to analyze relevant data. To ensure access to the most up-to-date labor market data, we subscribe to premium database services provided by the Economic Research Institute. To match potential job requirements with individuals' capabilities, we rely on the most comprehensive, powerful software available. For example, we utilize transferable skills software, including the McCroskey Transferable Skills Program (MTSP) which is widely recognized for its high degree of reliability and validity.

#### **PERSONAL INJURY MATTERS**

In lawsuits involving personal injuries, we deliver unique value by providing a complete picture. Determining earning potential is only the first

step in assessing damages and costs. Injured parties typically face ongoing costs for lifelong care and special needs for rehabilitation. In some cases, assistive technology may be required to restore some degree of function and earning capacity to these

impaired individuals.



While most litigation consulting firms offer capabilities only in vocational evaluation, Kincaid Vocational Services also has certified credentials and in-house expertise in both life care planning and assistive technology evaluation. Our capabilities and fully integrated approach deliver unique value for personal injury litigation, eliminating the coordination challenges and costs of contracting with multiple third-party specialists.

#### **MATRIMONIAL MATTERS**

Divorce proceedings can be expedited once each party's short- and long-term employability and earning potential are researched and evaluated carefully.

In cases of divorce in which a spouse has been out of the workplace for a number of years, we analyze education and prior work history along with the local labor market. This helps determine whether there is need for further education and training to help position the individual as a marketable candidate in a competitive work environment. If all prior

work history lies within a profession or industry for which there is little opportunity, our evaluation will determine employability through the use of a labor market survey. From that

evaluation, we also will set forth a reasonable expectation of earnings.

For cases in which an historically highearning spouse enters into a divorce and then claims to be unable to earn at that same level, our evaluation will objectively support or dispute such claims. Such an evaluation is particularly valuable in determining equitable child support and alimony.

#### **LIFE CARE PLANS**

Life care planning is an important component of the expertise our firm brings to personal injury litigation.

This process assesses the lifetime health, education and rehabilitation needs of parties suffering catastrophic injury, and then projects the costs of meeting those needs. Medical equipment, home or institutional care, transportation, therapies, surgery and home structural adaptations are examples of long-term needs considered in developing a life care plan.

To be effective for litigation purposes, life care plans require uniform application of standard practices for assessing these needs and calculating costs, along with careful documentation of sources and methodologies. Accordingly, Kincaid Vocational Services investigates multiple sources of funding for each element in the plan as the basis for cost projections.

Respected for his expertise in life care planning, Dr. Kincaid on occasion is called to critique the methodology used in plans submitted by doctors, nurses and other practitioners who are not specialists in this analysis.

#### **ASSISTIVE TECHNOLOGY EVALUATION**

Assistive technology encompasses a wide range of devices and training designed to mitigate the limitations of individuals with functional impairments, allowing them to work and earn income to their maximum potential. Wheelchairs, prosthetic aids, customized computers or telephones, and other workplace accommodations are common examples of assistive devices. Evaluating this technology for appropriate application in individual cases is a complex process requiring specialized skills, including hands-on training with the injured parties.

Incorporating this evaluation and the available technology in life care planning can have a substantial impact on the income potential of injured parties and litigation settlements.

As the benefits become more widely recognized, it is important to acknowledge that vocational evaluation consultants who are offering assistive technology evaluation services should have essential training, certification and experience.


Dr. Kincaid is an Assistive Technology
